# **Course Description**

This course is designed to introduce the use of statistics as a business tool. It introduces students to the basic concepts of statistical description, probability theory, and statistical inference. In particular, the course will emphasize estimation and hypothesis testing and, while introducing regression analysis. This course is a continuation of BANA 2372.

# **Learning Objectives**

Upon the successful completion of this course, students will:

- 1. Demonstrate understanding of introductory probability and statistics on tests.
- 2. Apply a statistical technique to analyze data
- 3. Describe how statistics are calculated and how to interpret them.
- 4. Perform basic analysis of data using a software program (e.g., Excel).

#### **Textbook and Resource Material**

**Required Textbook**: *Modern Business Statistics* by Anderson, Sweeney, et.al., 6th Edition.

This text is primarily an eBook incorporated into the SHSU Blackboard learning management system. You can purchase access to the book and its materials through Blackboard by clicking on the *MindTap* link in the left hand column of the Blackboard page for this course and then click *MindTap-Cengage Student Link*. The eBook required because of the online assignments.

## **Grading Policies**

Your final grade would be calculated as the sum of the following:

100- first exam

100- second exam

100- third exam

100- final exam

100- homework (10 points each)

80- quizzes (10 points each) (the highest 8 grades will be considered only)

20- attendance (1 point for each day present)

Scores obtained in class and homework are the sole criteria used to determine grades. Therefore, extenuating circumstances will not be considered in the determination of grades. Students can also earn a BONUS of 5 points if they do not miss any class.

Course grade will be awarded following the grading scale below

A = 600-540,

B = 539-480.

C = 479-420,

D = 419-360,

F = 359-0.

Grades will be posted on Blackboard. These will be used to calculate your final grade. It is the responsibility of the student to confirm if there are any inconsistencies in their grades. The instructor must be notified of any inconsistencies prior to the final exam.

**Exams** There will be three exams in class and one comprehensive final exam. The exams may consist of a combination of multiple choice, numeric problem and short answer questions. There will be **no** make-up exam. All exams are mandatory, and a missed exam will be recorded as zero unless excused by the instructor.

The final exam can be counted as two to replace the excused missed exam. The final exam will also replace the score of the lowest midterm exam if it is lower than the grade on the final exam.

Cheating is strictly prohibited. Any student suspected of cheating will receive a harsh penalty which can range from a zero on that exam to an F on the whole course at the instructor's discretion.

<u>Homework</u> will be given and announced through class website on Blackboard. You should submit your work online by the announced deadline. No late homework would be accepted. There will be 10 homework assignments in total. You are encouraged to work together in solving homework questions and help each other to do well. However, do not copy answers from your peers.

<u>Quizzes</u> There will be 11 quiz assignments based on the materials covered before that. The three lowest scores in the quizzes will be dropped. You will have to take the quizzes online. It will generally be assigned on Tuesdays after class and deadline to complete will be before the lecture on Thursday.

## Attendance, Excused Absences and Make-up Policy

Attendance will be taken in each class. Regular attendance is essential to succeed in this class. To incentivize regular attendance, points will be given for attendance in class. Students can earn upto 20 points for attendance (where each day of attendance is equal to 1 point). This means that attendance of at least 20 out of 30 days can earn you full points for attendance. Students will full attendance (all 30 days) will receive a BONUS of 5 points. You will also receive a point on attendance if you were unable to attend due to an excused absence.

It is not acceptable to be late to class or to leave early without discussing it with me in advance. It is University policy that attendance be recorded so that the administration can be notified on the 12th class day which enrolled students have never attended class. Also, we must report the final class date attended by any student who receives an F.

There will be **no** make-up for any missed quiz, homework or exam.

**Quizzes**: You can miss up to three quizzes without affecting your grade (since the best 8 out of 11 quiz scores will be considered).

**Homework**: If you miss a homework without a valid excuse, you will obtain a score of zero. Generally, the students will get seven days to complete an assignment. For an excused absence for homework, the excuse should apply to all seven days. In case of an excused absence, it is up to the instructor to determine the grading criteria for the missed homework.

**Exams**: If you miss a midterm exam due to an excused absence, the final exam score will be applied to the missed score. If you miss more than one exam or the final exam, it is up to the instructor to determine the provision based on the situation.

To qualify for an excused absence, students must have met the following conditions:

- 1. **Must have a university-approved excuse for missing an exam/assignment/attendance.** You can view the list of university approved absences (<a href="https://www.shsu.edu/dept/dean-of-students/absence.html">https://www.shsu.edu/dept/dean-of-students/absence.html</a>) or religious holy day absences (<a href="https://www.shsu.edu/dept/academic-affairs/documents/aps/students/861001.pdf">https://www.shsu.edu/dept/academic-affairs/documents/aps/students/861001.pdf</a>)
- 2. You must notify me within two working days of the exam/assignment/attendance.
- 3. You must provide a copy of the written documentation of the valid excuse at the time of notification of missing the exam/assignment/attendance. I must KEEP a copy of the

- documentation. The documentation must be valid for the DAY of the exam/assignment/attendance and not for any other day.
- 4. Please note that if you miss any exam/assignment/attendance without meeting one or more of the conditions explained above, you will receive a score of zero for that exam/assignment/attendance

**FREE PASS:** Each student will be given one free pass which can be used only once during the semester to get a 5 days extension on their deadline for either a homework or a quiz. No excuse is required for this to apply and can be used for any one homework or quiz during any time of the semester. However, for the FREE PASS to take effect, you need to notify the instructor before the deadline of that homework or quiz.

#### **General Classroom Guidelines**

## Student Absences on Religious Holy Days Policy

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. "Religious holy day" means a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20, United States Tax Code.

A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time.
